

SCOUTFITTERS GEAR RENTAL AGREEMENT

SCOutfitters gear rentals are subject to the following terms and conditions.

Check-In/Out: All gear must be checked out during rental hours the Thursday before reservation weekend. All gear must be returned during rental hours on the Tuesday after the weekend the gear was rented out for.

Gear Condition: All gear must be returned clean, meaning free of mud, dirt, debris, garbage, personal items, etc. All gear must also be returned dry, meaning not moist or wet. Returning gear that is not clean and/or dry is subject to a cleaning fee of \$30 per item and may negatively impact your ability to rent gear from SCOutfitters in the future.

Lost or damaged items: Gear that is not returned within one week of the required return date will be considered lost and you will be charged the full replacement cost of the item. By signing this agreement, you agree to pay the full replacement cost of gear that is lost, stolen, or damaged beyond repair. The determination of the condition of the gear is at the discretion of the program coordinators.

Duration of rental: For a traditional weekend, gear is to be picked up on the Thursday before the specified weekend and returned the following Tuesday. Exceptions may apply during university-recognized breaks and long weekends, which will be disclosed prior to the rental period. Any late returns will be charged for another full weekend and may impact your ability to rent gear in the future, as they may affect others' reservations.

Gear reservations: Reservations are first come, first served and all gear must be reserved online before it is able to be picked up. Reservations become available for the following month at 11pm the night of Trip Reveal.

Cancellation policy: Due to the nature of our operations, SCOutfitters Gear Rental is not able to offer refunds. However, you are able to cancel your reservation by emailing members@scoutfitters.org.

Assumption of Risk: You acknowledge that the possession, use, transportation, and/or storage of the Equipment may give rise to the risk of personal injury and/or property damage. You voluntarily assume all such risk and release and discharge SCOutfitters and the Equipment from any and all liens, liabilities, and claims arising in connection thereof. By signing this agreement you hereby release, waive, discharge, and covenant not to sue SCOutfitters or any subdivision thereof, and each of them, their officers and guides, (collectively, the "Releasees"), from and for any liability resulting from any personal injury, accident, or illness (including death), and/or property loss, however caused, arising from, or in any way related to, use, possession, transportation, and/or storage of the equipment.

Equipment use: As the renter, you are liable for ensuring proper gear use. By signing this agreement, you agree to comply fully with all laws and regulations related to the storage, use, and transportation of the equipment. You ("the Renter") assume full responsibility for any and all injuries, damages, or losses arising from the use of the equipment by the Renter or any authorized user, including but not limited to misuse, improper use, or accidents.

Responsibility: It is the responsibility of the renter to know how to use the requested equipment. You are required to watch all provided instructional videos on proper equipment use and storage before renting any gear. SCOutfitters does not guarantee that the equipment is in full working condition at the time of rental. It is the responsibility of the renter to check all

equipment prior to leaving the pickup location, and the renter must agree to accept the equipment "as is."

Liability: This Rental Agreement Form must be signed to rent equipment. The renter agrees to pay for any damages or loss of equipment and also agrees not to hold SCOutfitters, associated members, guides, or directors responsible for injuries, accidents, or other mishaps that may occur while using the equipment. By signing this form, I certify and acknowledge that I have read the above equipment rental policies and procedures for the rental program and agree to abide by these guidelines.
